We the undersigned George S. Harrison and Amos P. Aumock do hereby certify and return that Isaac George the minister of the Universalist Society of the village of Sinclearville in the County of Chautauqua and State of New York, having given public notice to the congregation of said Society at the Universalist Church in said Village of Sinclearville, the place where said Society statedly meet for public worship, that a meeting would be held on the 13th day of February 1858 at six o'clock in the afternoon at said Universalist Church for the purpose of incorporating, & for the election of Trustees of said Society to take charge of the Estate and property belonging to said Society, & to transact all affairs relative to the temporalities thereof, said notice having been given fifteen days before the day of election and said notice having been given on two successive Sabbaths preceding the day of said election, those being the days on which said Society statedly meet for public worship; that at the time aforesaid on said 13 day of February 1858 in pursuance of said notice the male persons of full age belonging to said Society assembled at said church & by a majority of the members present nominated and elected the undersigned George S. Harrison and Amos P. Aumont two of the members of said Church to preside at such election, receive the votes of the electors, to be the judges of the qualifications of such electors & to be the officers to return the names of the persons who by plurality of voices shall be elected to serve as Trustees.

We hereby further certify & return that at the time and place last above mentioned the following named persons were duly elected by a plurality of voices to serve as the Trustees for said Society to wit: Asa Dunbar, George S. Harrison and A. P. Aumock and that the name and title by which the said Trustees and their successors shall forever thereafter be called & known, shall be the "Trustees of the First Universalist Society of Sinclearville," and that the name and title by which said Society shall forever thereafter be called and known, shall be "The First Universalist Society of Sinclearville." We further certify that said notice was given & election was held according to the Statute in such case made and provided
