Certificate of Incorporation of a Board of Trustees for the Union Church  
and Church property in the Village of Edwards, St. Lawrence County New York

State of New York  
St. Lawrence County

We, the undersigned two of the members of the Church and Congregation hereafter mentioned in which Divine Worship is celebrated according to the rites of different Denominations constituting the Union Church—having been nominated by a majority of the members present for the purpose herein stated do hereby certify, that on the 25th day of March 1873, the male persons of full age, belonging to said Church and Congregation, and having no corporation did assemble, pursuant to due notice at the Church Edifice where they statedly attend for Divine Worship, in the town of Edwards in said county and did then and there elect by plurality of voices Robert Brown Sen. and John Newton 3<sup>d</sup> class, Henry Rushton and S. P. Rice 2<sup>d</sup> class and C. V. Haile 1<sup>st</sup> class as Trustees of the said Church and Congregation, to take the charge of the estate and property belonging thereto, and to transact all affairs relative to the temporalities thereof. And the said electors did then and there also determine, by the like plurality of voices that the said Trustees and their successors shall forever thereafter be called and known by the name or title of the "Trustees of the Edwards Union Church"—said Church now and forever to be owned equally by the following denominations namely, Presbyterians, Universalists, Methodist Episcopal and Baptists[.]

We further certify that on said day and at said place of election we were nominated for that purpose by a majority of the members present and did therefore preside at such election, and did receive the votes of the electors, and immediately thereafter we did make this certificate of the facts herein stated according to the statute in such cases provided.

(Union Church) and that the word Presbyterian immediately precedes the word Universalist & belongs in the place of Congregationalist which is erased, also the word Episcopal which is interlined belongs between Methodist & the word and & should read Methodist Episcopal[.]
