recorded March 22, 1946 at 9:30 A.M. in the Oswego County Clerk's Office in Liber 428 of Deeds page 214. This latter Deed covers the same premises and provides for reversion of the premises to the Convention if services are not held for two years.

On April 4, 1957 the undersigned went to Oswego, N.Y. and made a check of the indices there. He found that apparently the first parcel in the above deeds was conveyed to the Central Square Society by Emma A. Low by Deed dated December 23, 1916 and recorded December 29, 1916 in Liber 302 of Deeds at page 105 - the second parcel by Grace H. Wood by Deed dated November 19, 1907 and recorded November 20, 1907 in Liber 258 of Deeds at page 236, and the third parcel by Emma A. Low by Deed dated January 7, 1922 and recorded September 18, 1922 in Liber 327 of Deeds at page 536. The undersigned also checked the indices against the Convention from date of its Deed (above) to date - and found nothing except the Deed at #2 above.


Except as aforesaid, no examination of title was made.

CONCLUSION: - It appears to the undersigned that the title of the Central Square Church is in the First Universalist Society of Central Square subject to the possibility of reverting to the Convention in case services are not held for a two year period.



No one knows who designed or made the Tiffany-style leaded glass windows when the church was built in 1908, though according to a booklet on the history of the church, the congregation paid \$442.43 for "art windows and sash" as part of the \$4,666.29 total cost of construction.

Church members prize the windows, now insured for \$11,000, not only for their beauty—each window has dozens of vividly colored panes set by hand in lead—but also for their nontraditional imagery. Instead of the Christian religious scenes typical of windows from the period, each of First Universalist's windows bears a simple emblem surrounded by ornate borders. The emblems include the Greek letters alpha and omega, symbolizing beginning and end; a lyre, symbolizing music; and a dove, representing peace.

over \$32,000 through member donations to pay for a new ground-level entrance and an elevator to make their church accessible to all.

A recent celebration of the church's anniversary featured a service honoring the congregation's oldest member, 95-year-old Maurice Townsend, and the presentation of a history of the small but active church.

The motion was made, duly seconded and carried, that in the matter of the Universalist Society in Central Square, N.Y., buying or building a parsonage, the Executive Board of the New York State Convention of Universalists for the said purpose will release and return to the said Society, the amount of the then present value of the trust fund known as the Central Square Fund in Other Trust Funds, the bonds therein to be sold at market value and the mortgage (Moore) to be purchased by and taken over by the General Fund of the Convention at the amount appearing unpaid therein in the Treasurer's books at the time of the release and return of the Central Square Fund, on the following conditions:

- 1. The Treasurer of the New York State Convention of Universalists shall receive a certified copy of the resolution, requesting the release and return of the said Central Square Fund for the purpose of buying or building a parsonage, adopted at a legally-called parish meeting of the said Society to be signed by the President and Secretary of the said Society.
- 2. The said parsonage and land shall be deeded to the New York State Convention of Universalists on or before the release and return of said funds to the Universalist Society in Central Square and the Convention shall be furnished with opinion of legal counsel that its title to said property is good and marketable.
- 3. The said Society shall pay all expenses entailed in the transaction and all taxes, insurance, repairs, etc., hereafter involved in the maintenance of the said parsonage. The insurance policies, fire and liability, shall be made out to the said State Convention.
- 4. The said Society shall consent to the issuance and issue its demand note for \$3,000.00, to the said State Convention, on which the said Society shall pay interest at the rate of three per cent, July 1st and January 1st of each year, said note to be executed by the President and Treasurer of the said Society. Said note being intended to cover the amount of the Grace Strong bequest.

TWICE PER YEAR, JANUARY 1ST AND JULY 1ST, NYSCU HAS ISSUED CHECKS TO YOU FROM INTEREST EARNED FROM A TRUST FUND ESTABLISHED FOR YOU AND NINE OTHER CHURCH AFFILIATED GROUPS. THE INVESTMENT WAS IN A CERTIFICATE OF DEPOSIT WHICH MATURED IN JUNE 1994.

IN ACCORDANCE WITH A MOTION PASSED AT THE 1991 NYSCU BUSINESS MEETING, THE TRUST FUND WAS TO BE TERMINATED WHEN THE CD MATURED AND THE PRINCIPAL WAS TO BE RETURNED TO THE PARTICIPANTS AT THAT TIME.

THE PRINCIPAL OF THESE FUNDS WAS INTENDED TO BE AN ENDOWMENT FOR YOUR CHURCH. THE PRINCIPAL SHOULD BE PRESERVED AS AN ENDOWMENT AND NOT UTILIZED AS ROUTINE INCOME AND EXPENDED ON NORMAL CHURCH EXPENSES. ACCORDINGLY, WE RECOMMEND THAT THE PRINCIPAL BE PRESERVED IN AN ENDOWMENT FUND. IF YOUR CHURCH DOES NOT HAVE A WELL MANAGED ENDOWMENT FUND WE SUGGEST THAT, YOU TAKE ADVANTAGE OF THE UUA'S ENDOWMENT FUND FOR CHURCHES.


