Dear Rev. Lovejoy:

I have your letter of the 25th inst. Our rerecords indicate that the Second Universalist Parish of the Town of Minden, N. Y., in the spring of 1942 had a deposit of \$1,441.76 in the National Bank at Fort Plain, which represented or was known as the Peter Miller Fund. This was turned over to the Convention as a Trust'Fund for the Church of the Messiah at Fort Plain, and with the addition of what I imagine is interest, was so recorded on the Convention's books as \$1448.97 on June 16, 1942. There are two other small emounts also shown, to-wit, \$3.25 on March 22, 1943 " From sale of oldumetal O Minden Church", and \$50.00 on June 30, 1944 as "Sale old Parsonage", which our files indicate was the Parsonage at Minden. This makes a total of \$1502.22 from original sources in answer to your first question.

I have what purports to be an uncertified copy of the Will of one Peter Miller. From this it seems that the Second Universalist Parish of the Town of Minden was named as a legatee. You probably have access to a copy of this will, but I refer you to the Fifth paragraph which sets up a \$1000. Tor the Minden Parish with a John I. Zeller of Little Falls as Trustee. I believe Zoller was or is an attorney. Anyway on his death the Trust was to end and the Parish was to have the principal of the Trust itself. I have nothing to show what the actual situation was. Also in the Eleventh paragraph of the will \$1000 was left outright to the Minden Parish, after the death of the Testators widow, Catherine Hiller. Neither of these bequests mentioned the Ladies Aid Society of the Minden Parish. In this same paragraph however I notice two more \$1000 trusts to Zoller the same as above mentioned, one to the Parish itself, and the other to the Parish but to be expended under the direction of the Ladies Aid.

I have no other information about the Peter Miller estate, and suggest that you check the Will yourself. You could see it in the Surrogates Office if a copy is not handy.

I trust the foregoing will be of help.

It may be took late for us to do anything in Fort Plain. The law relating to dissolutions is different from that on mergers.

In a dissolution proceeding, a petition is presented to the court having jurisdiction, listing the assets of the congregation and the proposed disposition thereof; if the court approves the petition, that is the end of it. No notice to or approval of the "governing religious body" is required.

In a merger (which is referred to in the statute as a "consolidation"), on the other hand, each church involved must separately present a petition to the court and obtain the consent of its "governing religious body," if any. Thus we can block a consolidation but not a dissolution.

Yet another provision of law dealing with "property of extinct churches" allows a "governing religious body" to declare a church over which it has jurisdiction extinct if the church has either (a) failed for two consecutive years next prior thereto to maintain religious service according to the discipline, customs and usages of such governing body, or (b) has had less than thirteen members paying annual pew rent or making annual contributions towards its support. The governing religious body may take over all the property of the extinct congregation and either manage it or dispose of it and apply the proceeds to its stated purposes. In the case of a congregation that is "hanging on by the skin of its teeth," for example, the Convention could take title to the property but allow the congregation to continue to use it. If the congregation folds, the Convention already has title to the property; if the congregation revives, the Convention has the option of giving the property back.

What it boils down to is this: since it cannot be predicted in advance if a congregation will dissolve or consolidate, the only way we can preserve our options is to take a more proactive role by actively monitoring the activities of our member congregations -- especially the weak sisters -- so that we will be in a position to declare them extinct and take over their property, if we so choose, before they decide to dissolve.

I will check to see if there are any reported decisions dealing with the Bristol or Herkimer (or other) churches.

#### Greetings:

I am presenting this letter of intent in response to previous meetings and dialogue relative to the transfer of the Church of the Messiah to the Southern Episcopal Missionary Diocese of New York. The purpose of transfer being the establishment of a diocesan center to encompass the following:

One: St. Michael's Archangel Diocesan Center and Church of the Messiah.

Two: The Dioceses of New York Anglican Clinical Studies program. Three: St. Michael's Societal University program, (a division of

Holy Trinity College and Seminary, Nashville, TN.)

Four: St. Lukes Family Counseling Outreach Program.

Five: Diocesan Education Program for the enhancement of the Laity.

All of these programs are dependent upon the appropriate legal transfer of the church property to the Southern Episcopal Diocese of New York.

Whereas, the appropriate transfer of property being legally instituted, the Southern Episcopal Diocese of New York will insure and protect the following for the benefit of the religious nurturing of the Universalist Church of the Messiah, Fort Plain, New York.

One: That the Universalist congregation will be entitled to the inclusive use of the church property for all events that they may desire with respect to appropriate scheduling and that the Universalist will enjoy full antonymy of their religious expression without any interference from the S.E.C.

<u>Two</u>: That the Universalist congregation will retain its present time of weekly worr 'p of Sunday religious services to be continued at en o'clock a.m.

Three: That the Universalist congregation's present contract th the Senior citizens center will be respected and remain the same hen the church is transferred to the Southern Episcopal Diocese of New York.

Four: That all programming for St. Michael's Diocesan center be open to the inclusiveness of the Universalist Congregation.

<u>Five</u>: That all legal fees procurred relative to the transfer of church property be assumed and paid for by the Southern Episcopal Diocese of New York.

<u>Six</u>: That restoration and financial obligations of providing the ongoing maintanence of the church property upon transfer be the sole responsibility of the Southern Episcopal Diocese of New York.

May 21, 1997 Dear Gill, Received your letter of April 21st and you have it correct, as of June 23, 1996 The Universalist Church of the Messich, Fort Plain had their last church Revice, The membership of the congregation has declined to around 30 members of which only about 10 attended Church Revoices, and many of whom are elderly and or no lorger living in Fort Plain area. We had our 100th anniversary of the Laying of the Cornestone May 2, PS 96 - May 2, 1996. The Church is located on corner of Mohawk & Center St. Fort Plain, n-y. Influence of the Universalist Church in this section of the Mohawk Valley dates back to 1825 but it waen't until 1832 that "The First Universalist Church Society of Minden was organized. The new frame church at the corner of Mohawk + Center St. was dedicated on Christmas Way, 1833, the first Church to be leeted in the village of Fort Plain, which had been incorporated only a y. earlier, By 18 74, it was found nessary to remodel the building + rededication services Were held, Again in 1880 the building was enlarged + remodeled. As The yrs passed the ald building was found to be inadequate + by

(2) 1896 plans for rozing the ald edifice and creating the new bluilding had been Completed. Laying of the cornerstone + its dedication occurred during the pastorate of Rev. Herbeit W. Can. The church served as a liberalizing force in the community during those years, 1879-1900 of the Clinton Liberal Institute in Fort Plain. The institute was under the management of the Universalist denomination & a majority of its boarding students were from Universalist families.
