

**Newfane, Niagara Co. NY
(Olcott)**

We, the presiding officer of the meeting of the First Universalist Church of Olcott, Niagara County, N.Y., called, assembled and convened for the purpose, among other things, of incorporating the First Universalist Church of Olcott, N.Y., and electing trustees thereof, and two of the members present and voting at such meeting, pursuant to Sec. 193 of the Religious Corporations Law of the State of New York, do hereby make, sign, execute and acknowledge this certificate of incorporation and do certify that it was determined at such meeting as follows:

First: That the First Universalist Church of Olcott, an unincorporated Church having its place of worship in a brick building on the east side of Lockport Street, in the Village of Olcott, Niagara County, N.Y., and commonly known as the Universalist Church, should become incorporated.

Second: That said corporation should be known by the name of The First Universalist Church of Olcott, N.Y.

Third: That such corporation should have three trustees.

Fourth: That the first annual election of trustees of said The First Universalist Church of Olcott, N.Y. should be held at the church edifice, in the afternoon of the first Monday in January, 1916.

Fifth: That the principal place of worship of The First Universalist Church of Olcott, N.Y. is located on the east side of Lockport Street, in the village of Olcott, Niagara County.

Sixth: That Albert N. Bradley was elected trustee, to hold office until the first annual election of trustees thereafter.

Seventh: That James A. Martin was elected trustee, to hold office until the second annual election of trustees thereafter.

Eighth: That Cicero F. Stout was elected trustee, to hold office until the third annual election of trustees thereafter.

Ninth: And we do further certify that we have filed with the County Clerk of the County of Niagara the affidavits of Rev. Harry M. Wright, Cicero F. Stout, Benjamin Stout and A. Harold Coates, dated and verified November 20th, 1915, November 20th, 1915, October 16th, 1915, and November 20th, 1915, respectively, relating to said notice, the reading and posting thereof, and to the action and what took place at said meeting, and we respectfully refer to said affidavits, and each thereof, so heretofore filed with said Clerk.
