

Victims Are Laid to Rest

THE FINAL FUNERAL SERVICE HELD THIS AFTERNOON Funerals of Five of the Ladies Injured in Wednesday Evening's Tragedy Held Yesterday—Injured Doing Well

The funeral of Mrs. Elbert J. Moore which was held at the family residence this afternoon at 1 o'clock marked the final obsequies of the victims of last Wednesday evening's disaster. The attendance at this funeral was limited to the family and intimate friends of the deceased, and the services were simple but very impressive. The interment was in this city.

The funerals of five of the deceased victims of the accident were held yesterday, two of them being double ones. The services in each case were very impressive and the attendance of relatives and friends was very large, while the passage of the funeral procession through the streets was watched with intense sorrow by all.

The Southside Baptist church was the scene yesterday morning of the double funeral of Mrs. John Coats and Mrs. Eugene Shaw, who for many years had resided within the shadow of its walls. The church was crowded with friends of the deceased and the ceremony conducted by the Rev. Charles E. Petty was impressive in the extreme. The attendance included a large delegation of the members of the Order of the Eastern Star, from Canisteo, of which Mrs. Shaw was a member. The bodies were taken to Friendship on the 11:40 train for interment.

The double funeral of Mrs. Ruth Patchin and Mrs. Joseph Hallett was held from the family residence, No. 18 Davenport street, yesterday afternoon, and was attended by a large concourse of sorrowing friends and relatives. The body of Mrs. Hallett was buried here, while that of Mrs. Patchin was taken this morning to Greenwood for burial.

The funeral of Mrs. Fred Boughton was held at the family residence on Marshall avenue yesterday afternoon and a large gathering was present to pay their final tribute to the deceased friend in the solemn funeral service. The body was taken this morning on Erie train No. 2 to Binghamton for burial. A special car was provided for the relatives and friends, a large delegation of whom accompanied the family on their sad mission.

The condition of the four victims of the accident continues favorable. Mrs. Clark and Mrs. Rowley are doing as well as could be expected at St. James Mercy Hospital and Mrs. Bond is resting as comfortably as possible at her home on Main street. The condition of driver Elisha Quick is as good as could be expected when the great mental strain he is under is considered.

The inquest into the accident will be resumed by Coroner Sutton and the jury at the city hall tomorrow morning at 10 o'clock. Several of the members of the party who were in the other sleigh will be called as witnesses and the investigation will be completed in as thorough a manner as possible.
