DEATH OF H. H. GLINES

Decease of a Well-Known Roman with Neuralgia of the Heart

Hawley H. Glines died at his home on West Park at 9:30 A.M. Sunday, of neuralgia of the heart, aged 56 years. Mr. Glines had been employed as accountant in the store of W. W. Roberts. On Friday, Nov. 19, he was suddenly taken with heart difficulty, the attack being so severe that it was thought he could not survive it. He was taken to his home where he was confined to his bed until his death. He seemed at first to improve, but on Wednesday, Dec. 1, he suffered another attack, which was quite serious. After that he was weaker than before, but he recovered himself somewhat again and, on Sunday morning, seemed quite cheerful. He appeared so much better that he announced his intention of arising and dressing himself. At 9 o'clock, however, he was seized with another spasm that rendered him unconscious for a time. He evidently felt that his time had come, and, although he said nothing about dying, he called the members of his family around his bedside and, as they were standing there, he passed quietly away, without a struggle.

Mr. Glines was born in Lachute, Canada. In 1851 he was married to Miss Abby P. Sawyer of Grafton county, New Hampshire, a sister of the late Mrs. N. Haselton. Thirty-four years ago he came here with his family and was at first employed as locomotive fireman on the Rome, Watertown & Ogdensburg Railroad. Three months after he came here, while he was engaged in firing a shifting engine around the freight yard, he lost his left leg. His foot caught in a frog, and before he could extricate it the engine ran over it. For thirteen years afterward he was employed as accountant in the master mechanic's office here. The following twelve years he was with H. W. Pell, as accountant. After that he worked for Spencer & Wilson of Oneida, Smith & Putnam, the Rome Trestle Company and W. W. Roberts. He was collector of the fifth ward for several years. He was a member of the Ancient Order of United Workmen, an insurance society that pays \$2,000 on the death of each member. He was recorder of that body for some time, and held the office of financier at the time of his death. The deceased had been a member of the Universalist Church of this city for many years, and for the last six or eight years of his life was secretary of the board of trustees.

Mr. Glines was one of the most pleasant and genial of men, always having a kind word for those whom he met. Almost everyone in Rome knew Hawley Glines, and to know him was to esteem and respect him. It is doubtful whether he had an enemy in the world. He was steady and faithful to all the trusts imposed in him, and his death will be a source of sincere

regret to all who knew him. Besides his wife, three children survive: Alfred E. Glines of San Francisco, Cal., Mrs. J. C. Skaden of Durhamville, and William H. Glines of Richland. Mr. Glines' mother, now 80 years of age, resides with his sister, Mrs. John Sweet, at Woodstock, Canada West [now Ontario]. He also leaves a brother and four other sisters, Albert Glines and Mrs. William Cowan of Winnipeg, Manitoba, Mrs. N. Stone of Beaver Falls, Minnesota, Mrs. Charles Stackhouse of Ottawa, and Mrs. J. H. Hutchins, of Iliion.

The funeral services will occur at the house at 1:30 and at the Universalist Church at 2 P.M. on Thursday. The Ancient Order of United Workmen will attend in a body.
