—ROY Durrin of Salisbury is now lodged in the Herkimer jail charged with assault in the second degree, alleged to have been committed on the person of Goldie House, the 12year old daughter of Clark House, of (Stronglis?) Corners. The crime is alleged to have been committed Sunday at Plummersville, a hamlet situated near the Dolgeville water reservoir. The little girl lives with Burrell Rice [her grandfather], who resides about half a mile north of Salisbury Center. She told Mr. Rice of the affair and he immediately communicated with District Attorney Ward. That official went up to Salisbury and investigated the matter. Durrin was arrested and was arraigned, waived extradition and was held to await the action of the grand jury, which meets in Herkimer in December. He was unsuccessful in an attempt to secure bail and was taken to the Herkimer jail. Durrin is about 26 years of age and unmarried. His reputation is not of the best. The people of Salisbury are highly enraged at the dastardly crime alleged to have been committed by Durrin, and express the hope that he will be punished to the full extent of the law.

Accident Victim Dies in Hospital Mrs. Goldie Ives, 50, Was Injured Oct. 4 on Florence-Redfield Highway

Mrs. Goldie Ives, 50, who was injured in an automobile accident Oct. 4 on the Florence-Redfield highway, died at 5:35 o'clock this morning in the Oneida Hospital.

Mrs. Ives suffered a compound fracture of the left leg when the car in which she was riding left the highway and overturned. Also injured in the mishap were Elmer Frye, Florence, [who fell asleep at the wheel], driver of the car which contained Mrs. Ives, and also his two children, Virginia, 3, and Robert, 2. The four were taken to the Rome Hospital and removed to the County Hospital Oct. 8. Mr. Frye and his children are still patients at the latter institution.

Mrs. Ives had been employed as housekeeper at the Frye home in Florence.

She was born Oct. 15, 1891, in Salisbury Center, daughter of Clark and Winifred Strait House. She was married to Edward R. Ives, St. Johnsville, who survives with a daughter, Mrs. Heman Sponable, Salisbury Center.

Coroner Thomas A. Cox was called. Cause of death was given as shock and hemorrhage by a coroner's physician.
