EDWIN L. SLITER

Edwin L. Sliter, a former resident of Cooperstown and a prominent Mason, died Wednesday night of last week in Faxton Hospital at Utica, where he had been a patient for three weeks. Mr. Sliter was a former Otsego county Superintendent of the Poor.

Mr. Sliter, a salesman for the Daniel Green company of Dolgeville since 1893, was a trustee of Dolgeville Lodge 796, F. & A. M.; Oriental Chapter 305, R.A. M.; Mohawk Valley Consistory, Utica; Little Falls Commandery 26, Knights Templar; and Ziyara Temple, Nobles of the Mystic Shrine, Utica. Mr. Sliter also was a member of the Mohawk Valley Country club, Little Falls, and Fort Schuyler Club, Utica. He was a trustee of the Universalist church for twenty years.

Mr. Sliter was born in the town of Springfield, a son of Horace and Celinda Bliss Sliter. He moved to Dolgeville in 1895. He married Laura O. Faville, deceased, July 7, 1902, and Constance Mullins, Louisville, Ky., April 23, 1927.

Surviving are his wife, a son, Lindol, Canada Lake, and a sister, Mrs. Fred Chapin, Dolgeville.

The funeral was conducted Saturday from the home in Dolgeville by the Rev. C. A. Moulton, pastor of the Universalist Church.

EDWIN L. SLITER DIES AT UTICA
Dolgeville Resident Was in Hospital Three Weeks; Active in Lodges

DOLGEVILLE—Edwin L. Sliter, 70, passed away at the Faxton hospital in Utica at 7:20 Wednesday night. Mr. Sliter had undergone a serious operation recently and had been confined to that hospital for over three weeks.

He was born in the Town of Springfield December 22, 1870, son of the late Horace and Celinda Bills Sliter. He came to this village in the year 1895 and has made his home here ever since. He was twice married, the first time July 7, 1902, to the late Laura O. Faville of this village; the second time to Miss Constance Mullins of Louisville, Ky., on April 23, 1927. He had been connected with the Daniel Green company in this village for the past 49 years in the capacity of salesman.

Mr. Sliter was prominent in Masonic circles as well as in numerous other social and civic groups. He was a member of the Universalist church of this village and served as trustee for 20 years. He was a trustee of the Dolgeville Masonic Lodge, 796; he also belonged to the Oriental Chapter of Masons in this Lodge, the consistory of Utica, the Commandery of Little Falls and the Siyara Shrine of Utica. He belonged to the Mohawk Valley Country Club and the Fort Schuyler Club of Utica.

He is survived by his widow, whose mother, Mrs. James H. Mullins of Louisville, Ky., is visiting her; one son, Lendol F. Sliter of Canada Lake and one sister, Mrs. Fred Chapin of Dolgeville.

The funeral will be held from the home on South Main street Saturday afternoon at 2:30. The Rev. Clinton Moulton will officiate and burial will be made in the Dolgeville cemetery.
